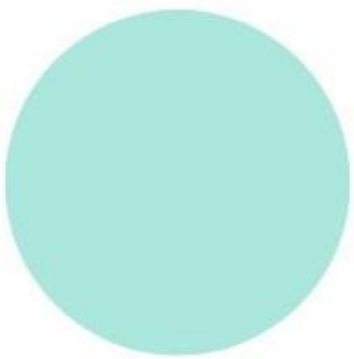

A DATASET OF EU LEGAL AND POLICY INSTRUMENTS FOR THE DIGITAL WORLD

This CEPS legislative dataset is an updated version and successor to a Bruegel dataset that was most recently published on 6 June 2024. Publishing an update now is appropriate because the European Commission has published several strategy documents that indicate what we might expect in the months to come.

The dataset is comprised of two tables:

- **Table 1:** Legislative measures relevant to digitalisation that were enacted in previous terms; a few legislative proposals that are still active; and ongoing EU policy initiatives that are likely to lead to new legislation in the foreseeable future.
- **Table 2:** Governmental and non-governmental bodies at EU level that contribute to the implementation and enforcement of legislative measures related to digitalisation.

This is the fourth edition of the EU dataset. It provides a comprehensive status update for the middle of the first full year of the 2024-2029 mandate.

This CEPS dataset is an EU-oriented companion to the [Dataset of international legal and policy instruments for the digital world](#) that the same authors published as a CEPS dataset on 6 May 2025.

OUR GOAL

It goes without saying that there has been an absolute explosion of new EU laws and regulations that are relevant to the digital world. Even the best experts struggle to keep up with this torrent of legal and policy instruments. The authors will continue to provide successive editions of this dataset because it's important that the research community have tools to help them make sense of this tsunami of legislative measures.

This CEPS dataset of EU law and regulation benefits from prior work. In the 2014-2019 legislative term, the European Parliament's Policy Department called for studies to assess the overall results of the legislative term. The [De Streel and Hocepiet \(2019\)](#) report on the legal characteristics of the Digital Single Market (DSM) provided a workable taxonomy of EU legislation, which [Marcus et al \(2019\)](#) used as a basis for assessing the economic results of the same EU legislative measures. An [earlier update to this body of work by Kai Zenner](#) further extended that analysis to cover EU legislative measures in the early years of the 2019-2024 legislative term. The authors of the current dataset then published three editions of the [Dataset on EU legislation for the digital world](#) as a Bruegel dataset in July 2023, November 2023 and June 2024. The authors gratefully acknowledge all this previous work.

An important common characteristic of all these datasets was the **classification of policy measures into a taxonomy of thematic areas**. The current international dataset follows the same taxonomy as the June 2024 dataset of EU legislation. We classify the measures depending on whether they primarily relate to (1) research and innovation; (2) industrial policy; (3) connectivity; (4) data and privacy; (5) intellectual property rights (IPR); (6) cybersecurity; (7) law enforcement; (8) trust and safety; (9) e-commerce and consumer protection; (10) competition and the EU Single Market; (11) media; and (12) finance.

In **Table 1**, the **enacted measures** appear in dark green and are listed within one of the 12 categories in order of their respective dates of enactment. A URL (hyperlink) is provided to an official copy of the Regulation or Directive in question, and its official number appears in the text. **Measures that are in the legislative process** appear in medium green in order of the date on which the proposal was submitted, again with a hyperlink to an official copy of the legislative proposal, the number of which again appears in the text. Planned initiatives are measures that have been announced but not yet formally proposed to the Parliament and Council. They appear in light green, once again with a hyperlink to the relevant Commission document – most often, either the *Competitiveness Compass for the EU* (COM(2025) 30 final) or else the *Commission work programme 2025*

(COM(2025) 45 final); alternatively, if a public consultation or a Call for Evidence is ongoing, we point to that.

Table 2 provides a list and taxonomy of the governmental and non-governmental bodies that in one way or another contribute to the implementation and enforcement of EU legislative measures that relate to digitalisation. The thematic taxonomy is the same as that used in Table 1, beginning with research and innovation, and continuing with industrial policy. Only EU bodies that have a role in implementing EU law relevant to digital services are included. Member State implementation bodies are not shown, nor are any expert groups that serve solely to provide the European Commission with high-level input and advice with the drafting of delegated or implementing acts. In Table 2, we distinguish between (1) EU institutions, (2) Executive agencies, (3) Decentralised agencies, (4) Governing boards, (5) Independent bodies, (6) Advisory bodies, (7) Networks of Member States, and (8) European Standardisation Organisations (ESOs).

NOTEWORTHY DEVELOPMENTS SINCE JUNE 2024

Our goal from the outset was to publish new versions of the dataset of EU legislation on an **as-needed basis**. There was no need to publish a new dataset of EU legislation during late 2024 or early 2025 because no new legislative proposals were on the table. Today, however, many Commission plans are now in motion.

Some important shifts are visible relative to the previous term. In at least one respect, what has *not* changed is noteworthy – most experts advocated a slowing down of new legislation to give businesses and the Member States an opportunity to catch up, but this isn't apparent it seems in the Commission's current planning.

The new plans reflect a substantial shift in priorities. In line with the Draghi Report and the Letta Report, a new focus on EU productivity is prominent, together with a focus on regulatory simplification and completing the EU Single Market. We expect a greater focus at EU level on defence going forward – a complex exercise, inasmuch as defence is primarily a Member State competence. We also anticipate less focus on any new initiatives to regulate digital platforms, due in part to the changed character of the transatlantic relationship.

How well the new focus on simplification will play out in practice over the course of the new legislative term remains to be seen. In short, **simplification is not simple!** The first noteworthy initiative in this direction by the new Commission was the Omnibus I Directive that seeks to amend three EU laws¹ to reduce allegedly overlapping reporting

¹ The Omnibus I Directive seeks to reduce reporting obligations in CSRD, CSDDD, and Taxonomy. There are now four Omnibus legislative proposals. They do not appear in our table because they do not create new laws.

requirements dealing with sustainability, human rights and corporate governance. In doing so, the Commission has [totally disregarded the Better Regulation process](#) that they committed to follow with new legislative proposals – and consequently, large parts of the legislative proposal are unconvincing. One can only hope that future simplification measures can be better planned... and better thought through.

SOURCES, LIMITATIONS, AND DISCLAIMERS

The authors have attempted to ensure that the information provided is accurate but we make no guarantees. Much of the information in our tables, especially information about measures that have already been enacted, is based on standard, publicly available sources. There is, however, a huge amount of material that potentially could have been included – we cannot promise that we captured every instrument that is potentially of interest. With that in mind, we very much welcome your input.
